**ORDER:** -

The Director of Collegiate Education has forwarded

the application submitted by the Thirukkazhukundram Education

Research and Training Centre to open an Unaided private

college in the name of Annai Theresa Arts & Science College.

The Director of Collegiate Education has stated that the

management has provided the following:

1) An Endowment of Rs.20/- lakhs (Rupees twenty lakhs only)

has been created in the joint name of Director of Collegiate

Education and the Thirukkazhukundram Education Research and

Training Centre with the Tamil Nadu Transport Development

Training Centre Limited. To be paid one year before

the Finance Corporation Limited.

2) The management has purchased 10.20 acres at

Kalpakkam Road, Thirukkazhukundram.

3) Agreement in stamp paper to abide by all

conditions prescribed by the Government.

2) The Government have examined the proposal carefully

and they permit T.K.M. Education Research & Training Centre

to open a Co-Educational College in the name and style of

Annai Theresa Arts & Science College with the following

courses from the academic year 1997-98.

i. B.Com. and one for a class in each of the following

ii. B.B.A.

iii. B.Sc. Computer Science having a class in each

iv. B.Sc. Bio-chemistry.

3. The management is permitted to start the college

during 1997-98 temporarily at Navin Mahal Kalyana Mandapam, Thirukkazhukundram and it should be shifted to the permanent building

during 1998-99 to be constructed in the land mentioned in

paras (ii) above.

4. The permission granted in para 2 above is also subject to the following conditions:

(a) Affiliation from the University of Madras should be maintained for the college from the year 1997-98 and onwards before the commencement of all courses of study.

(b) The land mentioned in para 1(f) above should not be utilised for any purpose other than college purpose.

(c) The Government will not grant any financial assistance at any time.

(d) The management should satisfy all the conditions prescribed in G.O.Ms.No.858, Education, dated 15.7.89 and G.O.Ms.No.244, Higher Education dated 17.5.97.

(e) All other courses of study except Science Arts and Commerce courses, allowed by the Government/University should be conducted.

(f) The teaching and non teaching staff shall be appointed as per the yardstick and they should possess the qualifications prescribed by the University.

(g) The management should not collect capitation fee or donation in any form other than the admissible fees as per the prescription of the Government.

(h) The management shall collect Tuition fees, Special fees, Application fees, Registration fees, Laboratory fees, Security deposit only as per the rates prescribed by the Director of Collegiate Education/Government.

(i) The management should strictly follow the guidelines issued by the Director of Collegiate Education during admission time and should fill up 50% of the seats as well as additional seats by adhering to the reservation policy of the Government.

(j) If the management creates a situation causing the closure of the College for any reasons, the Government will take over.
